- **Prevention** - Applies farm biosecurity practices to their property/business to reduce the spread of pests, weeds and diseases.
- **Recordkeeping** - Can show evidence of biosecurity activities (i.e. training, procedures, logs, etc).
- **Management** - Demonstrates a high level of understanding of animal health and welfare.
- **Collaboration** - Works with other producers, industry and/or government to improve biosecurity.

The winner will be invited to receive their award at the Livestock SA Industry Dinner on 19 November and will receive a prize of \$1000 in addition to an Adelaide Oval RoofClimb Experience for two.
